My personal response to: House Bill 3075 summary, *"The Act makes changes to the gun permit and transfer process.* **People that have no criminal record and have had their guns/weapons/firearms before 2020 should be exempt from any new firearms/weapons/magazine capacity laws; people's concealed permits should also be exempt from reapplying: people will continue to renew said permit per usual without further reapplying, unless they have passed their renewal period.**

Modifies the firearm permit provisions of Ballot Measure 114 (2022). Specifies where a person may apply for a permit to purchase a firearm and adds an eligibility requirement ~ this is already in place and seems redundant

Provides that information obtained during the application process and during the criminal background check and maintained within the database of permit holders is exempt from disclosure as a public record ~ this is already in place

Extends the time, from 30 to 60 days from receipt of the application ~ the process already can take more than 30 days. I feel mandating it to 60 days just gives more time for "lawmakers" to push their agenda regarding firearms, magazine capacity, and permit laws into affect. by which a permit agent must issue a permit to a qualified applicant or mail reasons for a denial in writing to the applicant.

Increases the maximum fee that may be charged for an initial application for and renewal of a permit ~ of course, because we the people of Oregonian are not taxed enough!

Specifies the portion of the fee payable to the Department of State Police for conducting a criminal background check ~ People already pay a fee for the background: adding another fee? Adding fees will not deter those who feel it is their constitutional right to carry and protect their family: the elderly and young who cannot defend themselves. Establishes alternatives to a firearms training course or class ~ what alternatives? This is not clearly spelled out. There are many places to take a class! I feel that online courses should not be permitted, only in person classes! that may be used to satisfy the requirement of proof of completion of a firearm safety course for the permit.

Provides that permits are not required for firearm transfers until July 1, 2026. ~ **How exactly will this change the current ORS transfer laws?**

Establishes a temporary exception to the permit requirement for the transfer of certain firearms until July 1, 2028. Again, how exactly will this change the current ORS transfer laws?

Establishes a permanent exception to the permit requirement for active duty law enforcement and military. Modifies the affirmative defense language for the large capacity magazine provisions of Ballot Measure 114 (2022). Provides that a challenge to legality of the Act must be commenced in the Circuit Court for Marion County.

Declares an emergency, effective on passage "~ What emergency?

Why does it feel there is a constant push to penalize responsible gun owners in Oregon? I vote No to House Bill 3075 and its parent Ballot Measure 114 (2022).

My husband and I own a meat processing facility, as a very small business we are taxed beyond belief. My husband also does mobile farm butchering ~ different firearms for different animals. This bill is proposing to make running the farm butchering difficult: more taxes, limits, red tape and hoops. If HB 3075 will we have a processing facility to process farm and wild game animals that feed families?
