Dear Members of the Oregon Legislature,

I am writing today to voice my strong opposition to House Bill 3076, which directs the Department of Justice to study the establishment of a state gun dealer licensing program. This bill is yet another attempt to chip away at our Second Amendment rights, under the guise of “studying” gun sales. This bill is not about public safety—it's about creating a framework for future gun restrictions. If we allow this to pass, what's next? A state registry of all gun owners? More taxes and fees on firearms? Oregon lawmakers have already pushed unconstitutional gun control measures—enough is enough.

I urge you to reject HB 3076 and any future legislation that seeks to undermine our Second Amendment rights.
