Dear Members of the Oregon Legislature,

I am writing today to voice my strong opposition to House Bill 3076, which directs the Department of Justice to study the establishment of a state gun dealer licensing program. This bill is yet another attempt to chip away at our Second Amendment rights, under the guise of "studying" gun sales. A Direct Violation of the Second Amendment

The Second Amendment clearly states that the right to keep and bear arms "shall not be infringed." Yet, time and time again, we see efforts like HB 3076 attempting to erode that right through excessive regulations and bureaucratic red tape. The

government should not have the power to decide who can and cannot sell firearms beyond the already rigorous federal standards in place.

This bill is not about public safety—it's about creating a framework for future gun restrictions. If we allow this to pass, what's next? A state registry of all gun owners? More taxes and fees on firearms? Oregon lawmakers have already pushed unconstitutional gun control measures—enough is enough.
