Re: Support for HB 3568 - The Seafood to Schools Act

Dear Chair Neron, Vice-Chair Dobson, Vice-Chair McIntyre, and Members of the Committee,

On behalf of the Bay Area Chamber of Commerce and our 451 business members serving Coos Bay, North Bend, Charleston, and the surrounding areas, I am writing to express our strong support for House Bill 3568, the Seafood to Schools Act. This legislation presents a unique opportunity to bolster our coastal economies, support the fishing industry, and provide nutritious, locally sourced proteins to students across Oregon.

Key Provisions of HB 3568:

- **Department of Education Allocation:** Appropriates \$600,000 for distribution to the Oregon Coast Visitors Association (OCVA) to promote seafood in public schools through educational programming, marketing, procurement support, and product development.
- **Department of Agriculture Allocation:** Provides \$200,000 to implement local food incentives and develop seafood products suitable for public school nutrition programs.

Anticipated Benefits:

- Economic Support for Coastal Communities: By integrating Oregon-landed seafood into school nutrition programs, HB 3568 directly supports our fishing industry, leading to job creation and economic growth in coastal regions.
- Educational and Nutritional Advantages: Introducing students to locally sourced seafood enriches their diets with healthy proteins and fosters an appreciation for Oregon's maritime heritage.
