Dear Chair Tran, Vice-Chair Grayber, Vice-Chair Lewis, and members of the House Committee on Emergency Management, General Government, and Veterans, As an active tourism advocate in Crook County and owner of a small business, I am writing to express my strong opposition to HB 3556.

Tourism is a cornerstone of Prineville and Crook County's economy, fueling local businesses, creating jobs, and enhancing our region's quality of life. Our natural beauty, outdoor recreation, and cultural heritage make this a sought-after destination, and strategic tourism investments have been instrumental in strengthening our economy—including the success of our lodging sector.

Collaboration between our local DMO, Explore Prineville, along with Visit Central Oregon and Travel Oregon, has been critical in expanding tourism development and marketing efforts, particularly during non-peak seasons. These efforts drive year-round visitation, providing job stability, supporting small businesses, and ensuring a sustainable economy.
