RE: Testimony In Support of HB 3838: Home and Community-Based Services Workforce Standards Board

Chair Grayber, Vice-Chairs Muñoz & Elmer, and members of the House Committee on Labor and Workplace Standards,

I am proud to submit testimony supporting HB 3838, establishing the Home and Community-Based Services Workforce Standards Board.

Oregonian's population is aging. In June of 2024, deaths exceeded births for the first time in Oregon's recorded history. ¹ Oregon's home and community-based care workforce has not kept up with Oregon's aging population and has left gaps in care for these individuals.

49% of direct care workers rely on public assistance, such as Medicaid, food stamps, and cash assistance.² There is a 51% annual turnover in direct care jobs, leading to instability in care.³ These workers deserve a voice in shaping their industry and the care they provide. A workforce standards board sets industry-wide standards that give workers a voice in improving wages, working conditions, and care quality.
