My name is Brittney McCartney, and I am a single mother of two children living in Port Orford. I currently work as a house cleaner and hold several part-time jobs to support my family. While I am grateful for the work I have, the reality is that making ends meet is often a struggle. I am testifying today to express my support for Senate Bill 1047, and to share how this bill could greatly benefit my family and the broader Port Orford community.

As a single mom, I strive every day to provide my children with stability and a sense of security. Our town of Port Orford holds so much promise, and I have dreams of seeing my children grow up here—surrounded by the beauty of the Oregon coast and within a supportive community. However, like many others in small towns, we are faced with limited economic opportunities. The local economy is struggling, and jobs that pay a livable wage can be few and far between.

A golf course, though it may seem like a luxury to some, could be a key driver of economic development in our region.
