Dear members of the House Judiciary Committee,

I am writing in strong opposition of HB 3075. This House Bill will overnight make hundreds of thousands of law-abiding Oregon citizen's criminal's overnight with the 10 round magazine ban. As many of you are probably unaware most 10 round magazines manufactured at this time can be modified to accept more than 10 rounds which makes them illegal under this legislation. Also, most handguns come with a standard capacity magazine of over 10 rounds, this alone is an undue burden to Oregon citizens. This alone will make myself and my wife who is former law enforcement criminals overnight.

As for the permit to purchase section of House Bill 3075 all this will do is make it harder for law-abiding and especially low income and minority Oregonians to purchase a firearm. It also has increased the application fee of \$65.00 under Measure 114 to \$150.00 which will almost automatically make it impossible for approximately 30-40% of Oregonians. It will also be an undue burden to first time gun buyers and first-time hunters because as the bill is written the prospective permittee will need to furnish a firearm for the live fire portion of the class, thus it makes it impossible for them to apply for the permit, because under Oregon law it is illegal to borrow a firearm without a valid background check thru a FFL, which you cannot obtain without a permit if this measure passes. It will do nothing to keep firearms out of the hands of criminals who wish to do harm to others. It will also be an undue burden to first time gun buyers and first-time hunters because as the bill is written the prospective permittee will need to furnish a firearm for the live fire portion of the class, thus it makes it impossible for them to apply for the permit.

Also, as far as I know and can find there is no officially sanctioned training program nor trainers/teachers for this permit process in place. This therefor is a direct violation of the second amendment of the United States and Article 1, section 27 of the Oregon State Constitution as it denies or delays a constitutional right.

There is also no fiscal impact statement for this legislation. Measure 114 also did not have a fiscal impact statement. Measure 114 will cost the state 50 million dollars the first year and 48 million every year after that. How much will House Bill 3075 cost Oregon taxpayers???

Most law-abiding Oregon citizens have or will not ever commit a crime involving a firearm. Most crimes committed with a firearm are committed with illegally obtain

firearms with magazines over 10 rounds, do you think a permit to purchase and a limit to how many rounds a magazine can hold with make them rethink their actions. I DO NOT!!! If a person wants to commit an act of evil they will find any means possible to do it.

House Bill 3075 and Measure 114 are bad legislation and a direct violation of the Second Amendment of the United State and Article 1, section 27 of the Oregon Constitution and I urge you to vote no on this.
