

Dear Chair Pham, Vice-Chair Anderson, and Members of the committee,

My name is Helena Birecki and I am writing on behalf of Climate Reality Project Portland Chapter in support of SB 54, a bill which would provide life-saving access to cooling during heat waves for renters in multi-family buildings 10 units or larger. As climate change continues to impact the health of Oregonians by increasing high temperatures, overnight temperatures, and lengthened heat waves, we join the Oregon Just Transition Alliance and many other organizations in asking that the effective date for the bill be as soon as possible.

Climate Reality Project Portland Chapter advocates for climate justice and public health, and the provisions of this bill supports both. As other testimony already published on OLIS states, when it's 80 degrees outside, it could be 95 degrees or more inside, especially in an upper floor apartment. In fact, a Detroit-based study found that the average indoor temperature in homes without air conditioning was nearly 25 degrees fahrenheit (13.8 C) higher inside than outside¹. Especially when coupled with humidity as is common in the Portland Area, those are dangerous conditions², especially for individuals who are elderly, babies or young children, or have pre-existing health conditions.

We would like to highlight that SB 54 is flexible and would allow landlords to bring in portable cooling units, eliminating the need for building retrofits or increased electrical capacity. This means that there is limited cost to the landlord for this potentially life-saving benefit to residents.

Oregon's legislature can further support the swift and affordable implementation of this bill by reinvesting in the Rental Home Heat Pump Program. The first round of funding for the Rental Home Heat Pump Program helped accomplish over 2,961 projects across 22 counties, with nearly half the funds targeted at low- and moderate-income rental properties and affordable housing sites including rented mobile homes and RVs.³ Reinvesting in this crucial program would allow small landlords to comply with SB-54 and provide needed cooling without raising rents.
