As other states are stepping up with substantial investments in their regional technology ecosystems, Oregon must prioritize innovation if we want to remain competitive.

A Call for Sustained Investment

From our extensive engagement with Oregon's innovation landscape, we strongly urge the following:

- Maintain full funding for Regional Innovation Hubs to ensure that economic opportunities are available across all regions.
- Continue supporting the SBIR Matching Grant program, which empowers Oregon companies to secure essential federal innovation funding.
- Preserve investment in the Commercialization Gap Fund, a crucial resource that brings research to market-ready products.
- Recognize the strategic importance of these programs in strengthening Oregon's economy for the long haul.
