RE: Request to Move House Bill 3556 to the House Committee on Revenue Without Recommendation

Chair Tran, Vice-Chairs Grayber and Lewis, and Members of the Committee,

On behalf of the Lincoln County Sheriff's Office, we urge you to move House Bill 3556 to the House Committee on Revenue without recommendation so it can receive the thorough financial and policy discussion it deserves.

Tourism draws millions of visitors to Oregon's scenic counties and cities each year, bringing economic benefits but also placing immense strain on public safety services. Law enforcement agencies, in particular, experience increased demands as visitor numbers rise, requiring additional resources to ensure the safety of both residents and tourists. HB 3556 is critical for Lincoln County and other communities affected by tourism, ensuring that we can maintain safe and sustainable communities for both residents and visitors. Moving this bill to the House Committee on Revenue will ensure the financial implications and necessary policy adjustments are fully examined, allowing stakeholders to engage in a meaningful discussion about how to best support tourism-impacted communities.

The rising number of visitors directly impacts law enforcement agencies. Tourism-related incidents lead to increased calls for service, higher arrest rates, more traffic-related accidents, and additional strain on jail capacity and court systems. However, despite these increasing demands, current law restricts how local governments can use new or increased Transient Lodging Tax (TLT) revenue, prioritizing tourism promotion and facilities over essential public safety services.

ORS 320.350 requires that 70% of all new local TLT rates and increases established after June 30, 2003 be dedicated to tourism promotion and tourism-related facilities, leaving only 30% available for discretionary use. This allocation

does not account for the direct public safety impacts of tourism, leaving law enforcement agencies without the necessary funding to respond to the influx of visitors and associated safety concerns effectively.

The effects are tangible and the data in Lincoln County demonstrates these impacts clearly. Between 2019 and 2024, visitors accounted for roughly 31% of all jail bookings. In 2024 alone, visitors accounted for 19% of Sheriff's Office arrests, 11% of Sheriff's Office crime victims, and 39% of Sheriff's Office traffic citations. Additionally, our enforcement division responded to an average of 1755 calls per month, with peak tourism months exceeding that average by more than 11%.

HB 3556 would provide much needed flexibility for highly tourism-impacted communities like Lincoln County to use TLT funds for critical law enforcement and public safety services. Ensuring these funds can be used to support emergency response efforts is not only a matter of public safety—it is essential to sustaining tourism itself. Visitors expect a safe environment when they travel, and maintaining strong public safety services is just as critical to tourism as promotion and marketing.

For these reasons, we strongly urge you to move HB 3556 to the House Committee on Revenue without recommendation, allowing for a full and informed discussion on how to best support law enforcement agencies and the tourism-impacted communities they serve.
