Dear Members of the Oregon Legislature,

I am writing today to voice my strong opposition to House Bill 3076, which directs the Department of Justice to study the establishment of a state gun dealer licensing program. This bill is not about public safety—it’s about creating a framework for future gun restrictions. If we allow this to pass, what’s next? A state registry of all gun owners? More taxes and fees on firearms? Oregon lawmakers have already pushed unconstitutional gun control measures—enough is enough.
