As a retired public safety officer who served in both California and Oregon for a combined service of 31 years. I am disappointed in my Oregon legislators who were installed to protect ALL of the constitutional rights of Oregonians who consistently work to violate the most basic constitutional 2nd amendment right. I've watched over my career as Oregon legislators regulate Oregonians from a position of fear, and socialist uninformed control tactics rather than a position of real informed studies or communications with real Oregonian constituents.
