Subject: Support for House Bill 2153 – Increasing Jet-A Fuel Tax to Sustain and Enhance Oregon's Aviation Infrastructure

## Dear Committee Members,

The Grant County Regional Airport strongly supports House Bill 2153, which proposes a modest increase in the jet fuel tax to provide critical funding for the Aviation System Action Program (ASAP) and the Critical Oregon Airport Relief (COAR) grant program. These programs are essential to maintaining and improving Oregon's aviation infrastructure, which plays a vital role in supporting local economies, public services, and community safety.

At the Grant County Regional Airport, we have experienced firsthand the value of these grant programs. Increased funding is crucial to sustain these services and ensure airports can meet the evolving needs of the communities they serve.

Additionally, ASAP and COAR grants play a key role in strengthening systemwide resiliency. They enable airports to upgrade aging infrastructure, improve safety measures, and prepare for future challenges, including adapting to new aviation technologies. These state-level investments are also essential in leveraging federal dollars, as many large-scale projects depend on matching funds to secure significant federal contributions. Without consistent state funding, Oregon risks losing these opportunities and falling behind in critical infrastructure improvements.

The Grant County Regional Airport is an essential part of our community, contributing to economic development and providing critical public services. Continued investment through HB 2153 will allow us—and airports across the state—to maintain safe, efficient operations while preparing for future growth and emerging challenges.
