Re: SB 5515, Oregon Department of Education, Recovery Schools Funding

Dear Co-Chairs Lieber and Sanchez; Co-Chairs Sollman and Ruiz; and members of the Joint Committee On Ways and Means Subcommittee On Education:

My name is Michael Durchslag and I am currently the Board President of the Associations of Recovery Schools (ARS). I am writing in strong support of funding Oregon Department of Education recovery high schools in the 2025-27 biennium at the full \$12.7 million requested by the agency.

As the only national organization that supports recovery high schools, ARS was incredibly excited when this historic funding through HB 2767 was passed in 2023. We have used your legislation as a model when we talk with other states across the country as well as the federal level. Oregon became a true leader in adolescent recovery support services through HB2767, which includes specific efforts in expanding recovery high schools into rural areas.

Recovery high schools are highly researched, highly effective schools designed specifically for students in recovery from substance use disorder (SUD) and co-occurring disorders. Research shows that students who choose to attend a recovery high school are more than twice as likely to remain sober than their counterparts who return to a non-recovery high school. Research has also shown that students at recovery high schools have higher attendance rates, higher graduation rates, better learning outcomes and better quality of life. Given that substance use disorder rates in youth and young adults in Oregon continue to outpace the national average, it is more important now than ever before that we commit to providing the necessary resources for young Oregonians to be successful.
