Dear Co-Chairs Ruiz and Sollman and Members of the Education Ways and Means Subcommittee,

We are the Co-directors of Early Childhood CARES – Lane County’s early intervention and early program since 1992. We have provided information about what we do and also data on how we are doing with the current level of funding. And we attached letters from parents who currently are receiving EI/ECSE in Lane County services from Early Childhood CARES.

We urge you to fund EI/ECSE programs with an additional \$24 million for the 2025-2027 biennium to be able to maintain our current service levels. This is a total of \$432.8 million.

And additional funds would allow us to come closer to meeting the adequate service level needs of children. The funding for EI/ECSE programs is in ODE’s Grant-in-Aide budget. **SB 5515**

Early Childhood CARES is the early intervention and early childhood special education (EI/ECSE) for all children in Lane County. We provide specialized services and supports to all birth to school age children who have developmental delays and/or disabilities.

- EI/ECSE services are mandated under federal (IDEA) and state laws.
- No wait lists are permitted and services must be provided within a required timeline.
- All services and supports are free to eligible children.
- Each eligible child has an IFSP (Individualized Family Services Plan) to meet their needs

Children are eligible for services for a variety of reasons including: developmental delay, speech and language delay or impairment, autism, orthopedically impaired, deaf or hard of hearing, visually impaired, severe social emotional disturbance, traumatic brain injury or deaf/blind.

Services are provided through home visits, parent-toddler groups, supports in community-based preschools, specialized preschool classrooms, autism classrooms, communication classrooms, and services in the areas of speech/language, motor, behavior, and autism. Children also receive developmental screenings and evaluations. Parents receive individual education and supports, Parent Chats and other trainings on topics of common interest and a monthly newsletter.

Staff are highly qualified professionals including speech and language pathologists, occupational and physical therapists, EI/ECSE teachers and home visitors, nurses, school psychologists and educational assistants.

Early Childhood CARES regularly collaborates with all 16 of Lane County’s school districts and all local early childhood programs and agencies to more effectively serve children and families in Lane County-- expanding programs, identifying needs and gaps and eliminating any duplication. And

Early Childhood CARES leadership serves on many cross-sector state and local boards, advisory committees, and leadership teams to ensure collaboration and alignment.

Early Childhood CARES annually serves over 1700 children throughout Lane County in all of the 16 school districts. And over 400 children are thoughtfully transitioned from Early Childhood CARES into kindergarten **prepared for school**.

Average annual increase in children served year to year has been 3-5% pre pandemic and 10-13% post pandemic. We anticipate the growth rate returning to 5%.

Funding has not kept pace with the growth and needs.

EI/ECSE services are funded based on a funding formula developed in 2009 and updated in 2011. The formula uses caseload projections and projected costs of providing adequate service levels for children who have mild, moderate and severe needs. Below is a table showing the percentage of children in Lane County who received adequate service levels in each category.

Note: Lane County’s adequate service level data is similar to all EI/ECSE programs across Oregon.

We urge you to fund EI/ECSE programs with an additional \$24 million for the 2025-2027 biennium to be able to maintain our current service levels. This is a total of \$432.8 million. And additional funds would allow us to come closer to meeting the adequate service level needs of children. The funding for EI/ECSE programs is in ODE’s Grant-in-Aide budget. **SB 5515**

My son James is now 4.5 years old. After his first birthday my husband and I started noticing differences from how our older two children had matured. He was not speaking and his manner of play was very unique. Going into his 18 month appointment with his pediatrician we were already preparing ourselves for the possibility of an autism diagnosis. Sure enough at that appointment we were told he likely has autism and were handed a stack of papers about services we should pursue and given a pat on the head. While the news was not totally unexpected it was very shocking and in some ways devastating. We then **began our journey with Early Childhood CARES not knowing what to really expect.**

What we found was a group of people who loved children, who treated them with respect and kindness. Who taught us parents that kids with neurodivergence are just normal kids who see the world a little differently. **They worked with us every step of the way** to obtain state and country resources that were desperately needed. They worked with our schedule to find a program that fit for James.

They cheered James on when he started making amazing strides with his therapy. To this day we text some of his prior teachers who have no obligation to him anymore but simply want to stay involved because they care so much about James. Today James is a happy, communicative little boy. He is preparing to start kindergarten at a standard school. He is saying "I love you" and "thank you" and doing things we didn't know would be possible. **To say that he wouldn't have achieved these landmarks without Early Childhood CARES is an understatement.** Our family owes them so, so much for all they have done. **I can't imagine where he would be without the support of Early Childhood CARES.**

Please, please, please protect Early Childhood CARES and the amazing care they provide to hundreds of families across Oregon. They are doing the work of angels and **without them so many families would face an insurmountable struggle alone.**

Our family has a long history with Early Childhood Cares, going back to 2013 when our **son with Down syndrome** was born. Later, we became **foster parents for the state of Oregon** and we **welcomed many babies into our home who experienced a variety of developmental delays**. We've worked with EC Cares for about 10 children over 12 years, but this story focuses on one particular child, who I will call Tot for privacy.

Tot came to us in the middle of the pandemic. He was born very early and spent 8 months in the hospital. He was discharged with a ventilator, tracheostomy, central line, and feeding tube. When he arrived in our home, he couldn't lift his head. He was interested in toys, but couldn't reach out to grab them. Doctors told us that he might never walk or run or play like other kids. Just 10 days after Tot came to our home, we had his first early intervention home visit from EC Cares.

Tot spent most of his time on a blanket, watching our other kids play. Within a week, he was lifting his head. With the support of an EC Cares occupational therapist, he was soon sitting up while propped with pillows. An EC Cares physical therapist came often to work with Tot, and before long he was rolling back and forth. In just a few weeks, he'd made more progress than he had in months in the hospital. Speech helped us with feeding issues and our service coordinator was invaluablely supportive for everything.

Tot made progress no one anticipated. Within a few months, Tot crawled. Just 8 months after coming home, he was WALKING! **His team of EC Cares therapists was with us every step. They supported my husband and me when we had concerns, they celebrated the milestones, and they cheered him on to greater and greater successes.**

Today, Tot is nearly 5 years old. He is supported by those same EC Cares therapists in his school. Tot has overcome so much over the past 4 years. He still has a tracheostomy and a feeding tube, but all of the other equipment is gone. Tot runs and plays mostly like all the other kids. Most of his EC Cares therapists have been with him the entire 4 years, and we still celebrate his successes together. They've seen us through many hospital admissions, multiple cold & flu seasons, and 2 years of preschool. At our final IFSP meeting, there were some tears as we talked about how far this tiny, sick baby had come.

Having this team support us for 4 years has been incredible. **I don't think we'd be where we're at without them.** EC Cares isn't just some advice about development, they're a **lifeline for parents who have kids with developmental delays**. And having the support in our home was even more valuable. Those early months were so fraught with worry, between how very fragile he was and the ongoing pandemic, **having support come to us was critical**. We never could have taken him out to therapy offices, he was just too vulnerable.

Thank you to everyone at EC Cares for helping our boy THRIVE.

Due to the ECCARES program and excellent staff my son, Ezra, is better prepared to start his academic journey. Ezra, who is four years old, is attending Preschool as part of EC CARES. When he was two years old our pediatrician said he is exhibiting signs of autism, and we should get a diagnosis. We had to wait over a year to get an appointment and the proper autism diagnosis, during that wait we were able to get an evaluation by EC CARES and enroll him in preschool.

ECCARES has helped in many ways, not only academically, but also socially. When I take him to the park, because he's non-verbal around strangers his peers either don't interact with him or have negative interactions. ECCARES provides that safe space where he can learn how to behave around his peers and in a classroom environment. He has also begun speaking a few words and understands many other words. His speech therapist let us know he's likely to have Gestalt language processing (GLP) so we have taken a different tactic to help him with his speech and grow his vocabulary. **The amazing teachers at ECCARES have taught him so many things that we, his parents, wouldn't even think to teach him because we aren't trained professionals.**

His academic journey will be difficult, but with the help ECCARES has provided he will be prepared for kindergarten in ways we couldn't do on our own. As you know **education is a building event, and it becomes increasingly difficult to reach the next step if you're not prepared for the step you're on.** ECCARES has laid a great foundation for his journey so he may be able to build on it and **prepare him for his happy and productive adult life.**

To Whom it May Concern,

My family is writing to you regarding the importance of retaining and expanding the services offered through Early Childhood Cares (ECcares) for children experiencing developmental delays or living with disabilities. **These services offer access to resources and trained professionals that are irreplaceable.** Two of our children- 10 years apart- have both blossomed and made enormous progress through utilizing the ECcares program.

Our older son experienced many challenges with sensory processing. He needed assistance with improving both his fine motor and gross motor skills. It was difficult for him to follow directions and understand how to participate in classroom activities-especially with his peers. The ECcares **teachers that worked with our son gave us immense insight and invaluable advice** on strategies to help him develop further in these areas. With their preschool intervention, he was able to assimilate into a typical gen-ed classroom with his peers; this would not have been possible without their support.

We are a blended family now- with three children. At the time, I was a single parent in a one income household. It was a financially difficult time and without access to the free services ECcares offers, I did not have the resources to pay for private preschool to help him develop these necessary skills. He would have entered public kindergarten with his peers, who likely attended preschool and were much further developed socially and academically.

I'm not sure if you've stepped into a Kindergarten classroom lately, but I'm sure we can all recognize that class sizes are problematic, there aren't enough aides to help the teachers, and the teachers spend more time working on behavioral skills- like listening and following directions- than actually teaching the material. Without ECcares intervention, I can't imagine how much of a disruption our son (and other children of similar abilities) may have been to his classmates- ultimately impacting all of their educations. Instead, he was able to attain these critical skills by being given the opportunity to work with these valuable teachers through ECcares. **Today, he is a high achieving 7th grader with a 4.0 GPA and is very active in sports and social clubs. We are very grateful for the support we received from ECcares.**

Our youngest child is currently receiving services through ECcares. He is 3 1/2, autistic, and has some developmental delays. His ECcares preschool operates 4 days/week for 3 hours/day. When he first started school, he was considered non-verbal. Although he goes to speech and occupational therapy, the time he spends with his teachers and peers at school has been significantly more helpful! He is talking a lot now at school and home, he is making much more eye contact, he is also much more curious and social. He is not very receptive to therapy and doesn't enjoy going. That being said, he absolutely adores his teachers and loves going to his school.

I cannot even articulate to you how helpful ECcares has been in expanding our youngest child's skills- particularly social and language. **These teachers put their life work into helping our children. They are passionate about what they do and they work hard! They become a second family and a safe space for these children to grow and learn without judgment.**

It is absolutely appalling that parents/educators/members of the community are having to advocate for such a strong pillar in our community in fear that they may lose funding. They are the number one resource recommended by local pediatricians, therapy offices, schools and other parents. Whether or not you have children, I think we can agree on the importance of living in an educated society. **EVERY child has a right to an education-regardless of their abilities. Some children need more help than others.** If you cut this irreplaceable resource for our community, not only are you saying that these children don't deserve the same opportunities by neglecting their needs- but you are streamlining them into a gen-ed system that was never set up to manage their challenges. You will absolutely end up with dysregulated and disruptive children whose needs aren't being met- while simultaneously impacting the education of their classmates. This will contribute to an even greater teacher shortage than we currently have.

We live in a civilized society where **we can afford to take care of our vulnerable by providing the same access to opportunities for everyone.** ECcares has done so much for our family and it would be a huge disservice to these children and their families, educators, the school systems and our community if you cut this program. Do better.

Dear Oregon State Legislature,

My partner and I moved to Oregon amid the COVID pandemic back in February 2020; we had just given birth to our first and now only-child. After a few years of trying to settle into our new home, we **noticed a few delays with our daughters' development from crawling and walking to making sounds or not turning to us when we called her name.** We had little to no success when trying to find daycares that could help her developmental delays or when speaking to her main medical provider to get referrals to specialists. We were not sure if it could be associated with the pandemic's lack of socialization or complications due to her breech birth during my pregnancy, but **we knew we needed help, just weren't sure where to go from there.**

One rainy day our daycare wanted to speak with us, we met that afternoon, and they told us that they could no longer provide the care our daughter needed due to her lack of speech, unawareness of her surroundings and even having bursts of uncontrollable sobbing- we were dumbfounded by the news. That night I **searched online for anything that could help us and found ECCARES where I was able to complete an online application and soon after received a call within a few days. I felt an immense weight lifted off my shoulder** after that original call, **I remember having hope from that moment on.** I have nothing but gratitude from the person who called me from ECCARES and schedule our evaluation appointment to the therapists who evaluated my daughter and were able to validate all my concerns that I had been voicing to our pediatrician for the year prior. As of today, **my daughter has been attending the ECCARES program for over 2 years and it has been the most valuable program in our lives.** Her father and I work full-time, but **we've been able to stay connected with the staff at ECCARES from receiving daily pictures from her preschool class, to notes on her speech progress and soon she'll be entering Kindergarten well- equipped with everything she's learned. We feel completely confident in the care they've provided for our child as well as the patience and love they given her since the day they met her.** I highly recommend this program to everyone in our community and **hope it continues to not only be funded but to be expanded into more communities because I cannot imagine what our lives would be now without ECCARES.**

Our son, Luke Carranza, was diagnosed in utero with an extremely rare brain condition among others, including Hydrocephalus, Brachyurricephaly, Hypotonia, and more. Throughout pregnancy we were terrified of Luke's diagnoses and were afraid for our son's quality of life.

In addition to the invaluable occupational therapy provided by Early Childhood Cares, we would be remiss if we did not also explain how grateful we are for the equipment lending program through the agency. Luke has required multiple pieces of equipment from the lending library - bath chairs, gait trainers, standers, and more - to help him in his daily physical therapy and care needs. In all cases, these pieces of equipment have helped Luke develop the gross motor skills to allow him more bodily autonomy and have helped bridge the gap when insurance approvals were unfortunately too slow to accommodate the immediate medical need.
