Re: SB 1188 Support

As members of the Oregon Residential Ombudsman Public Guardian Advisory Board, ltco.info@rights.oregon.gov (ROPGAB) we are writing in strong support of SB 1188, an Act that directs the www.oltco.org Oregon Public Guardian and Conservator to make grants to help people who are leaving a hospital obtain guardianship services.

ROPGAB oversees the Office of the Long-Term Care Ombudsman (OLTCO) including its programs of the Residential Facilities Ombudsman (RFO), the Long-Term Care Ombudsman (LTCO) and the Oregon Public Guardian (OPG). The statutory directives for the Board also include advising the legislative Assembly on issues related to the agency, its programs, and the Oregonians served by the agency. The ROPGAB Board members represent decades of experience in geriatrics, mental health care, brain injury, long-term care, elder law, guardianship, advocacy for individuals with disabilities, and as caregivers ourselves.

We support SB 1188:

- Members of the Board have witnessed, either personally or professionally, individuals willing to act as a guardian for a friend or family member but who lack the financial resources needed to obtain a legal guardianship in Oregon (legal fees can range from \$2-10,000).
- This act provides much needed funds for local community resources or county guardianship programs to take on guardianship for incapacitated individuals closer to their home settings.
- This act provides funds for family members who cannot afford the legal fees to act as guardian for an incapacitated person.
- Many times, that incapacitated person can fall through the social services cracks if they don't qualify for public guardianship, or if OPG does not have the capacity to take on their case or the person ends up in a hospital setting long term if they cannot be safely discharged.
- This Act can provide solutions to prevent these issues from arising and take the burden off hospitals, social service agencies and more.

We urge you to support SB 1188 in this legislative session and are available for testimony or additional information if needed. We thank you for considering these vital services for the citizens of Oregon.
