This same developer has constructed a water ski lake amidst a water shortage and zoning violations, leading to a costly failure of a multi-million dollar

project.

In Deschutes County, residents recently learned of a developer aiming to establish a resort that would encroach on State Lands to build vacation homes. The community rallied together, and thankfully, the decision was made not to sell the land to this developer at this time.

The Urban Growth Boundary (UGB) is essential in preventing unchecked, large-scale development, a problem seen in states like Arizona and Texas, where housing construction is set to escalate beyond limits.
