The Oregon Constitution reads : Section 27. Right to bear arms; military subordinate to civil power. The people shall have the right to bear arms for the defence [sic] of themselves, and the State, but the Military shall be kept in strict subordination to the civil power[.]

The US Constitution reads: Second Amendment: A well regulated Militia, being necessary to the security of a free State, the right of the people to keep and bear Arms, shall not be infringed.

This submitted testimony for SB243 purports to "Requires the Department of State Police to study the efficiency of firearm transfer criminal background checks", but it is very clearly NOT that.

It may have started out as a study of background checks but has morphed into something unconscionable.
