## **Opposition to Oregon SB 210**

SB 210 is just another attempt in the long history of Republican initiatives designed to suppress voter turnout and thereby help their candidates get elected. Don't take my word for it, read the words of Republicans themselves :

Unfortunately these are not just words, Republicans go to great lengths to suppress voting. We're all familiar with the Brooks Brothers riot that stopped the vote count in Miami-Dade county Florida in 2000.
