Mail-in ballots are an invitation to cheat. Flood the zone with millions of ballots, no one there to see who is signing the ballots. No signature verification, no address verification, an election process that is hidden from the people and dirty voter rolls make it very obvious Oregon is intent on cheating and has been doing so for many years. If they refuse to keep voter registration rolls clean, we know that they are not following the rules of verifying signatures, or addresses, chain of custody, the elections they put on are just a pretend show to make Oregon citizens think real elections are taking place. But they are filled with fraud.

There are many ways to cheat in elections and Oregon Democrats, who control the election process from beginning to end, use all the tools to make sure they win elections.

1) The use of mail-in ballots has been studied thoroughly. It has shown that thousands of ballots are sent to ineligible voters at addresses no longer valid. This is not new. It's been happening ever since there has been Mail-In ballots used in Oregon..

2) Dirty voter rolls are used in Oregon and that's why Judicial Watch is suing Oregon. Oregon has been put on notice for years to clean up dirty voter rolls, but those who run elections in Oregon, especially Multnomah and, Lane counties, Oregon's largest counties, refuse. And the Secretary of State does nothing to insure election integrity, but claiming everything is fine, is so much easier than making sure our elections are secure.

3) It is the obligation of those running these elections to clean up the voter rolls. In Oregon the full time election employees don't remove those ineligible to vote: Voters who have moved, they don't update addresses, they don't remove those who have died, and keep adding illegals using automatic voter registration using the DMV, that is registering illegals to vote, who should never be allowed to vote but we see that Oregon officials who run the elections want to disregard the rules and use whatever means possible to cheat. They enable illegals to vote. They love dirty voter rolls with all those fake voters, they can inject when and where they need votes.

4) Oregon uses ERIC , [Electronic Registration and Information Center (ERIC)] software which supposedly helps to keep voter rolls free of ineligible voters, but in Oregon it seems beyond the capability of those who run our elections. The fact that Oregon has to be sued to do the right thing and CLEAN UP the voters rolls is pathetic and shows how that those who run elections in Oregon are not serious about voter fraud. They have always enabled illegals to vote. All the illegals needed was a bill with their name on it and they're good to go. No effort whatsoever is made to verify that only legal citizens vote because Oregon Dems WANT ILLEGALS TO VOTE. Look how lame the Voter Registration card that can be filled out online by illegals, they just need to check one box that asks "Are you a citizen of the United States of

" precinct voting puts an additional check as the individual must appear in person at each polling place. Since no personal appearance is ever required with mail-in registration and a mail-in ballot, it becomes trivial to vote under a fake or assumed name.

6) With Mail-In ballots anyone could be filling out the ballots. With thousands of ballots flooding the mailboxes of addresses are that are grocery stores or vacant lots, Oregon election employees are too lazy, or corrupt, to run elections to insure election integrity or they would never allow mass mail-in voting, with no checks and balances.

7) Mail-In ballots is a recipe for fraud and no one is surprised that we have fraudulent elections in Oregon. But Oregon officials just keep repeating the mantra that our elections are fine. That's ridiculous. Oregon uses all the tools to cheat: Mail-In ballots, no signature verification, no address verification, automatic voter registration [DMV], but still deny they cheat.

Just recently we've seen DMV caught cheating [but they don't call it cheating they call it making the same mistake over and over again], registering illegals to vote. To even try to claim that Oregon is not cheating when they use all the tools to cheat, given we have been using Mail-In ballots since 1998, is ludicrous. In the last four years we have seen all the cheats in all 50 states. There is cheating in all 50 states but not all 3000+ counties across the country. To try to claim that Oregon is the only state not cheating is preposterous. Oregon makes no attempt to clean up our elections, they use all the tools to cheat but somehow Oregon officials claim they are the only state in the US that is not cheating, but it defies all probability.

It is deliberate and intentional because dirty voter rolls make it very easy to cheat. They use the thousands of so-called registered voters, who are not ever going to vote, but sit on the voter rolls, to inject votes where needed to win elections.

8) Zero audits from 'our' government on 'our' elections. Oregon does not even allow election audits. During the recent DMV cheating they tried to downplay it, lying about the number of illegals registered to vote. They claimed 'they' had done an audit. A quickie audit was done and they told us, again, everything's great. So they are able to do audits, but not real ones that we ask for.

We have to demand access to the voting process, hands on access to see the physical ballots, count the ballots by hand and get access that Oregon Dems have denied. They refuse to have cameras monitoring drop boxes and refuse to have allow citizens to monitor the drop boxes. Again they do everything to cheat but deny they are cheating.

Mail- in ballots sent to residents that have moved away, don't live here, are dead, are fake and fill up the voter rolls with thousands of ineligible voters that are sitting on dirty voter rolls available to be used to prop up a losing candidate or a losing Measures ,, with the same playbook, "Whew, it was close but we pulled it out" we've heard so many times. Dems are cheaters. In Multnomah county they don't allow anyone to count the votes but a select group of, not poll workers, but paid 'on call' people choosen from a select list of people that they control, no newcomers or outsiders allowed. Their own special people who facilitate the cheat. They do not allow Republicans.

No signature verification. Anyone can be filling out the mail-in ballots. There is zero security that the intended recipient of the ballot voted. None. But there is much evidence that flooding the electorate with ballots means they will be many ballots to effect the cheat.

1-day in person vote- Then they can verify voter ID. Which they DO NOT WANT TO DO.

1-day in person voting [LIKE WE DID FOR DECADES] at precincts, WITH VOTER ID. The process was clean, voter ID was checked, precincts handled the voting process. Now it's a free-for-all cheating extravaganza, that no one trusts. Dems don't care. They are addicted to the cheat. They can't win without cheating. They don't care that we know they are cheating. They will deny it forever.
