	illegal ballot casting opportunities.
	More ballots are mailed to addresses than the addresses contain residents
	Votes are legally counted seven days after the election date. These ballots are supposed to be postmarked
	by the election date, yet they contain no postmarks.
	Thumb drives are used to transfer votes from one computer to another. These thumb drives can contain
	manipulative programs.
	Votes are tabulated by machines that have been proven to be easily hacked. Machines that we the people
	have been forbidden to inspect.
These	e are facts:
	More people are registered to vote in Oregon than are eligible to vote.
	Anyone can register to vote by supplying the last four digits of a social security number. Yet without the
	first five numbers, any four numbers will work as there is no way to verify that person
	The legislature has passed laws that undermine clean voter rolls. ORS 247.275 prohibits removing
	names from the voter rolls because they do not vote.
	Those names that do not vote are used fraudulently by those that need them.
	ral law requires reasonable efforts to remove names of ineligible voters yet Counties do not clean voter rolls.
	14 counties reported removing 5 or fewer voter registrations in a 4-year period.
	In a Washington County sample of 4,400 voter records. 13% were dead, one has been dead for 24 years;
	12 of those dead voters cast ballots in Washington County.
	In a Washington County sample of 248 records, 85 registered voters had moved out of Washington
	County and still voted in Washington County.
	Lane County had 85 voters registered at an address on Amazon Parkway—no one lives at that address.

	In Lane County, a Walmart parking lot has 12 registered voters.
	Anthony Hanson lived at an address in Portland for a total two weeks; somehow he got registered there.
	He now lives Baltimore, Maryland. Ballots for Anthony are still received at that Portland address.
	Every University of Oregon student gets 2 ballots; special interests seek to collect the excess unused
	ballots; the Service Employees International Union is one who collected excess ballots and then looked
	for volunteers to help to fill them out. Those volunteers were then told by the union how to fill out the
	ballots.
	Antifa has published instructions on how to vote more than once
	Interest groups search out vulnerable citizens, such as nursing home residents to get votes from them.
	They brag about how they assist blind elderly people with filling out ballots, quoting one, "I filled it out
	Not the way they told me to, but I filled it out."
There	e is no chain of custody for ballots;
	Oregon cannot tell you that your vote was counted; only that it was received.
	Once the ballot is separated from the envelope there is no way to ensure that your vote was counted;
	there is no way for 'we the people' to know that it wasn't replaced.
Signa	ture verification is ineffective.
	Signatures can easily be forged with machines
	Very high rates of ballot challenges and rejections are inherent in a vote-by-mail, signature verification
	system. 5,000 ballots were rejected in Clackamas County alone, in the 2022 election. Rejected too late to
	be cured.
	Those 5,000 ballots were either fake or legitimate; we will never know.
	In Washington County observers sought to challenge 230 signatures, but the vast majority were accepted
	despite the challenge.
	Once the ballot gets by the signature check there is no way to undo the harm, there is no avenue for
	appeal, no way to undo the problem
-	outerized systems present an inherent and undeniable security risk, compromising elections in ways annot be detected.
	It's been demonstrated that the Machines Oregon uses can be hacked in minutes
	Wi-fi modems are present in every single voting tabulator
	e most recent state election, Between 4:36 and 4:44 am on Sunday, May 29, 2022, witnessed their otal decrease by 6,371 votes.
	Between 8:32 pm and 8:36 pm on May 29, 2022, that vote total decreased by 3,855 votes.
	Between 4:57 am and 4:58 am on Saturday, June 10, vote totals decreased by 6,390 votes.
