Dear Lawmakers,

My name is Chad Kernutt and I urge you to please vote YES on SB-210 and send the choice for voting in elections to WE THE PEOPLE as a ballot measure. Voting was always meant to be an in person endeavor that was conducted on election day with employers releasing their workers for the day to go vote in person at a designated voting site. Eligible citizen voters were supposed to show up and provide an ID for verification of citizenship and non-felon status proving that they are the person they are claiming to be. Since moving from on site voting to mail in and drop off ballots and motor voter automatic registrations we've had all kinds of fraudulent activity both locally and nationally from over 1,500 illegal immigrants being registered to vote, to the point of drop off with drop boxes where people are filling out and dropping off other peoples ballots, to biased postal carriers and workers who knowing that certain areas have a high concentration of a certain voter group and could easily discard the mail ballots, all the way to the processing centers where they are engulfed in issues from terrible delays to personal errors and are subject to the biases of the people working behind closed doors, out of view of the public, who will be deciding which signatures will survive scrutiny and which ballots will get counted after workers can easily verify someone's party registration before even opening the ballot. This means that personal biases in people who may be lacking in integrity could easily lead to valid votes getting discarded to swing election results. Especially if it's done by multiple people in concert with each other. The whole process from start to finish is now ripe for fraudulent behavior and we've had cases of all these very things.

There is also the debacle of the 2020 election which is no conspiracy and democrats still have not been able to explain how there was 108% turn out nationally with all the swing states switching to mail in and drop off balloting including late voting. This means that there was 8% more votes nationally than there were registered voters. Explain that one to me, or the fact that there was 13 million more votes in that election than the average of elections since Bill Clinton up through Trump in 2016 which never saw a change in voters exceeding the 1 million mark. Well that's easily explained by the 8% higher vote count than there were registered voters. How strange.
