Measure, Appointment or Topic: SB210

I strongly oppose Oregon Senate Bill 210, as it threatens to undermine the wellestablished and highly successful vote-by-mail system that has served Oregonians for decades. Any changes to our election process should be based on clear evidence of necessity, not unfounded concerns that ignore the proven integrity and effectiveness of our current system.

Oregon's vote-by-mail system has been a model of success since its full implementation in 2000. By mailing ballots to all registered voters, the state has consistently achieved high voter participation rates. In the 2020 presidential election, for instance, Oregon recorded a turnout rate of 75.3% among eligible voters, reflecting the system's effectiveness in encouraging civic engagement.

Concerns about voter fraud in mail-in voting have been thoroughly investigated, and findings indicate that such instances are exceedingly rare. Between 2000 and 2019, approximately 61 million ballots were cast in Oregon, with only 38 criminal convictions for voter fraud during that period—a rate of about 0.00006%. These statistics underscore the integrity and security of Oregon's vote-by-mail system, demonstrating its success in facilitating accessible and trustworthy elections.
