My name is Erick Allen better know as "EA"; I am a Certified Substance Use and Mental Health Counselor with over 40 of lived experience, 10 years of which specializing in adolescent behavioral health and recovery. I currently provide direct clinical services as a contractor, often working 60+ hours per week to address the urgent needs of youth struggling with addiction, mental health crises, and systemic gaps in care. I urge you to \*\*pass HB 3197\*\* to allocate essential funding for youth services—a lifeline for Oregon's most vulnerable populations.

### \*\*Why HB 3197 Matters\*\*

- 1. \*\*Prevention Saves Lives and Costs\*\*
- Early intervention for youth reduces long-term societal costs (e.g., healthcare, criminal justice) and prevents tragedies. Underfunded services force families into crisis-driven systems, exacerbating disparities.
- In my practice, I've seen how limited access to counseling, harm reduction programs, and housing supports perpetuates cycles of addiction and homelessness. HB 3197's investments can break these cycles.
