I wholeheartedly support SD210 and here are some of the reasons...

- There are 100's maybe 1000's or more, Oregonians that don't vote as they have lost confidence in Oregon's voting system, they don't think their vote counts.
- No chain of custody as is demanded by law. When the ballot goes to the post office or given to someone harvesting ballot, there is opportunity for fraud
- Oct 2024, I found 53,237 Active voters on the voter rolls that had not voted for at least 7 year (as far as my history) could be longer. All of these voters receive the Nov 2024 Ballot. If history means anything, these ballots were littering the pavement, recycling bins, for people to pick up and vote fraudulently.
- They claim the signature verification would catch this but, this last election in Clackamas there were 10,000 signatures that didn't match, not because of fraud but because they were using the DMV digital pad signatures. Does your digital signature match your ballot?
- How about the Nursing Homes, do we know the voter voted or did someone vote in their place?
- Why do we have more voters on the voter rolls that we have people in Oregon eligible to vote?
- Clackamas allows the ballot envelope to be taped. With ballot harvesting legal in Oregon, what is to prevent a person from opening the envelope, X out the voter's intended candidate and circle the candidate the fraudster wants, tape it up and deliver to elections office or drop box? Nothing! Do you really think everyone is honest?
- 6/2024, we found 3,850 voters on the Clackamas voter rolls that had moved out of state and registered to vote at their new residence. According to the SOS guidelines at the time, these voters Will be cancelled, so we challenged each one, trying to help clean the voter rolls, but 3,618 are still on the Clackamas Rolls. Oh, now the SOS online guidelines say May be cancelled. Besides Military/ Students, which were not included in this list, and temporary workers, why do we keep sending Oregon ballots out of state.
- I submitted 41 challenges for voters that are dead, to Clackamas Elections and some have been dead for many years, one as far back as 2014. As of December 2024, that person is still on the voter rolls as inactive along with 14 others but there are 12 dead people that are active, meaning they will get a ballot delivered to their address.
- These are just a few incidents in my county, can you imagine what it is statewide.
- So, besides the possible illegal & Fraudulent votes, that are compromising our elections. How about the cost of sending all the ballot out, postage going out and returning them, the cost of the machines, software, licensing, paying for ERIC, the NGO that has all of our signatures from the DMV.
- We can get volunteers to do the hand counting at the precinct level and have the results to the election that night (or at least by the next day, not weeks)
- Total transparency, video tape the whole process
- Absentee ballots wills still be available to those that needs them
- Holiday for Voting in one day at your Precinct, Voter ID, (Proof of Citizenship), Hand counting,
- You can still sit leisurely at home with the voter pamphlet to figure who you want to vote for and just take your notes or a sample ballot with you.
- My question for all the people opposing this bill, if we could prove significant illegal and fraudulent vote, would you still want Vote by Mail, for your convenience?
