I have lived and worked in Rural PNW and urge you to act now. Postive protection Required for Oregonians' health and future safety. As a state Oregonians and this committee were unprepared to face the level of problems that this industrial food production has generated in Oregon, and how much damage would result.

We need a more proactive and adaptive management style to mitigate agricultural waste called CAFOs. This is an opportunity to slow down a freight train. This measure only applies to future operations, and we also need to address the violations of the existing operations.

Support SB 80. Buy us time to look ahead. Create a process to monitor and regulate this industry before permitting future expansions and new permits.

Once the damage is done on this scale it is irreversible.

Not being able to see Mount Hood is a serious concern. The level of emissions of greenhouse gas is similar to an entire metro area.

We need guardrails and regulations that reflect the true costs. There are parts of eastern Oregon and now into the Willamette valley that have seen a surge in terms of these types of applications. Where are the guardrails? How does this fitr into Oregons Climate plan.
