Public Testimony in Support of House Bill 3939

Chair Marsh, Vice-Chair Andersen, Vice-Chair Breese-Iverson, and Members of the House Committee on Housing and Homelessness,

Thank you for the opportunity to provide testimony in support of House Bill 3939. My name is Dan Cummings, and I am the City Manager for the City of Ontario. I am writing today to express our city's strong support for this critical legislation, which will provide essential infrastructure funding to support housing development in rural Oregon communities.

Ontario is proud to be home to the Veterans Village project, a vital initiative designed to address the housing needs of veterans in our community. This innovative development will provide safe, affordable housing for those who have served our country, offering not only homes but also access to supportive services that promote stability and well-being. However, like many rural housing projects, the Veterans Village faces a significant barrier: the lack of adequate infrastructure.
