Dear Chair Marsh, Vice-Chair Breese-Iverson, Vice-Chair Andersen, and Members of the Committee,

On behalf of the Central Oregon Regional Housing Council, I am writing to express our strong support for House Bill 3746. This bill is an essential step toward expanding middle housing options—such as condominiums—that provide attainable homeownership opportunities for Oregon’s working families.

Central Oregon is facing a severe housing shortage, particularly for middle-income households that earn too much to qualify for affordable housing programs but cannot afford the rising costs of single-family homes. Condominiums and other forms of middle housing offer a critical solution by increasing the supply of homeownership opportunities at price points accessible to working families, first-time buyers, and essential workers.

Unfortunately, Oregon’s current legal environment creates significant barriers to the development of condominiums. The threat of prolonged liability and construction defect litigation discourages builders from investing in these types of housing projects, limiting the availability of affordable homeownership options. HB 3746 helps address this issue by reducing the statute of limitations for construction defect claims, providing more certainty for builders while still ensuring homeowners have protections. This reform is key to incentivizing the construction of middle housing across the state.

Increasing the supply of condominiums and other middle housing types is essential for ensuring that teachers, nurses, firefighters, and other critical members of our workforce can afford to live in the communities they serve. For these reasons, the Central Oregon Regional Housing Council urges the Oregon Legislature to pass HB 3746 and take a crucial step toward increasing homeownership opportunities for middle-class Oregonians. Thank you for your leadership on this important issue.
