RE: Letter of Support for funding requests via Oregon Budget HB 5006

Dear Chairs, Lieber and Sanchez and Members of the Committee,

Thank you for the opportunity to provide comments regarding several funding bills and an appropriation related to the Oregon budget on behalf of Economic Development for Central Oregon (EDCO). EDCO is a private, non-profit organization serving the tri-county region of Crook, Deschutes, and Jefferson Counties whose mission is to promote sustained job growth and prosperous communities through traded-sector industry growth. We ask that you consider the following interests as a pathway to better economic outcomes for Oregon.

- **HB 2972 Workforce Re-entry**, Central Oregon's Deer Ridge Correctional institution was one of the pioneers of this programing by putting a WorkSource center on site to connect inmates to job and career opportunities post incarceration. Many of our employers have found skilled workers from this program and are willing to help these inmates find steady income.
- Oregon State University Cascades \$42 million funding request our 4-year students need support for mental and physical health and further remediation and expansion of our campus. It is the only University in Oregon without this type of support facility. This request is matched by student fees, donors and planned debt capital.
- Industrial Lands Funding Bills, like HB 2411– Having the fastest growing economy in Oregon, Central Oregon continues to add back industrial lands to our inventory in response to the significant absorption this past decade. We have over 2,000 acres of available industrial zoned land, and most of it needs infrastructure, not just roads but important utility infrastructure, lift stations and larger piping. We have had significant economic development projects pass on land acquisition of a regionally recognized priority site in Redmond due to the cost of infrastructure – land owned by the Department of State Lands (DSL). Please support industrial lands infrastructure bills and include the requested \$40,000 million in funds this session.

• We need new direct incentives, and existing legislation along with its recent amendments can now support additional key target industries.
