**RE: SB 141 – K-12 Accountability**

Dear Chair Frederick, Vice-Chair Weber, and members of the Senate Education Committee,

As members of the [Oregon Partners for Education Justice \(OPEJ\)](#), we would like to thank you for the opportunity to express our **strong support for SB 141**.

OPEJ represents a cross-cultural network of community-based organizations, culturally specific service providers, and education advocates who are championing an inclusive, equitable, racially just, and community-centered public education system for Oregon. Since first testifying on this bill, we have seen meaningful amendments that address key questions around its implementation. These changes clarify how the Oregon Department of Education (ODE) will establish a coherent and responsive accountability system that builds upon Oregon's 2019 Student Success Act.

SB 141 will advance a promising plan for K-12 investment and improvement by using common evidence-based metrics to track student outcomes and ensure the state has the authority and effective tools to provide targeted supports for school districts when needed. These are critical steps to accelerate growth and ensure school districts who struggle the most are bolstered by stronger partnerships between the State and local communities, not punished. **SB 141 will ensure Oregon doubles down on delivering a quality education for all, especially children who are not getting what they need to learn and thrive from the current system.**

**As we seek to close the achievement gap between the State of Oregon and other states, we must also close achievement gaps that have persisted for students of color, low-income students, and students with disabilities.** The changing federal education landscape makes this ever more important. With the recent changes to the National Center for Education Statistics (NCES) and looming federal cuts, Oregon must build our own robust system of accountability to support our historically underserved students. SB 141 helps meet this moment by requiring school districts to utilize disaggregated student data to establish growth targets across statewide metrics and develop equitable policies and programs to improve student outcomes. This data-driven approach ensures Oregon can independently track common metrics and close achievement gaps, regardless of federal uncertainty.

Given our current challenges, **now is the time for Oregon to take this opportunity and be clear and resolute: accountability means that student success isn't left to chance.** There must be clear expectations and a system of support in place to deliver quality learning and experiences regardless of student identity, zip code, or circumstances.

**We urge the committee to support SB 141.** This legislation is an essential step toward advancing a more just education system for Oregon's children.
