RE: Community Hearing on HB 5006 in La Grande at Eastern Oregon University

Dear Co-Chairs Lieber and Sanchez and Members of the Committee,

My name is Brenda Smith, I am the director of High Desert Partnership, a nonprofit organization that serves Harney County and rural Eastern Oregon. I am also a trustee on the board of Eastern Oregon University. I believe in our rural university and how it serves the residents of Harney County. I urge you to support EOU this legislative session.

Today, I am here to talk about the power of community and collaboration and share our plan to expand the work of High Desert Partnership and to ask for your support for our capital construction request for an Eastern Oregon Collaborative Center.

High Desert Partnership proposes establishing the Eastern Oregon Collaborative Center to serve ever increasing requests from groups in this region to work collaboratively using a model we have been practicing for nearly 20 years. A center in our region will benefit the state by providing more place-based coordination with state agencies in our rural outposts. Increased ability to leverage state resources to implement collaborative projects and also by reducing litigation when people are not working together. No other organization provides the level of support across a variety of topics that High Desert Partnership does. A center such as this does not exist anywhere in the region.

The center will be a base for collaborative partners, agencies and organizations working in eastern Oregon and will provide economic benefit in the region. This center will connect and grow community-based resources leading to greater community resilience in the region.

I believe this is no better time than now to invest in cultivating collaboration and building relationships in rural eastern Oregon. In Harney County, we have been through it all, floods, droughts, economic hardships, groundwater concerns, wildfires and more. Yet, we keep coming though and I believe this is in part due to our culture of collaboration. Let us show how we can expand collaboration for rural Oregon through our Eastern Oregon Collaborative Center.
