List of blatantly violated laws:

ORS 163.005 Sex Crimes

18 U.S. Code § 2256 Child pornography refers to any visual depiction, including photographs, videos, or computer-generated images, of sexually explicit conduct involving a minor, ORS 167.080 Displaying obscene materials to minors, 20 U.S.C. § 1232H Protection of pupil rights, ORS 163.693 Failure to report child pornography, 18 U.S. Code § 2258 Failure to report child abuse

ORS 161.450; ORS 163A.005(5)(x)(z)

18 U.S.C. § 1349, and 18 U.S.C. § 371, to illegally purchase and pay for "Adult Porn Books" and "Child Porn Books" that contain pictures, drawings, images, audio, video images and photographs of "children" or "minors" under the age of 18 years old as defined by ORS 419B.005(2); ORS 167.060(4), and 18 U.S.C. § 2256(1)

ORS 163A.005(5)(f) Using a child in display of sexually explicit conduct

ORS 163A.005(5)(g) Encouraging child sexual abuse in any degree

ORS 163A.005(5)(d) Sexual abuse in any degree
