Dear Senator Lieber and Representative Sanchez,

On behalf of Bridge Meadows, I write to express our strong and unequivocal support for **House Bill 3497, which establishes a visionary and much-needed Multi-Sector Plan for Aging (MSPA) in Oregon.** As the Executive Director of Bridge Meadows—intergenerational communities that support youth formerly in foster care, adoptive families, and elders—we see daily the critical importance of developing comprehensive, inclusive, and forward-thinking strategies to meet the evolving needs of Oregon's aging population.

Oregon stands at a pivotal juncture. By 2030, more than one in five Oregonians will be 65 or older. This demographic shift presents both profound challenges and extraordinary opportunities. HB 3497 answers this moment with the clarity and commitment it demands—uniting government agencies, community-based organizations, businesses, and advocates in a collaborative planning effort that reflects the diversity and dignity of all Oregonians.

A robust MSPA will help scale such innovations across the state, encouraging creative solutions and strategic investments that uplift all Oregonians.
