Dear Co-chairs Sollman, Ruiz and Members of the committee:

Through direct mediation services and educational programming, Resolution Oregon's network of Community Resolution Centers help to improve school success, reduce crime recidivism among youth and adults, resolve disputes faster and cheaper than courts alone, and help keep people housed.

The investment in Dispute Resolution supports public policy facilitations through Portland State University's Oregon Consenses and constituent mediation services through Resolution Oregon hosted by University of Oregon. Funds received for community dispute resolution pass-through the University of Oregon to provide services for low-income urban and rural community members all across the state.

Community resolution services are complimentary to other avenues of justice, and this investment saves the state millions of dollars each year. In housing stability mediation cases alone, the return on investment in Resolution Oregon for 2024 was about 3,000%, or an average of more than \$30M in saved downstream shelter costs, medical costs, and other costs that are known direct results of an eviction. The public and private cost savings from this investment are clear and undeniable.

Community dispute resolution is much more than good economics. Through community mediation and restorative justice, people find solutions that come from listening, connecting, and understanding. People are encouraged to seek legal counsel, and connected to resources to help them be informed and self-determine the agreement that can work for them.

In the last biennium, Resolution Oregon's network served over 35,000 community members in more than 10,000 cases. More that 5,000 youth and adults participated in over 1,500 skill building opportunities to improve their communication and conflict mangement skills. These services create a positive ripple through our committee and through all our lives.



Decades of survey responses indicate high quality and impacful services, such as: 83% of housing cases are resolved, 85% of survey respondents are satisfied with the outcome of the mediation, and 95% of respondants agree the process was fair.

Attached to this statement are a sample of letters submitted to Resolution Oregon in support of Communty Resolution Center grant funding. These letters highlight the ongoing impacts made by the services and eduational trainings that support school success, housing stability, increased public safety, and violence prevention.

With appropriate funding, Community Resolution Centers can quickly mobilize and respond to pressing and changing needs. Please continue to support Dispute Resolution Funding in SB 5525.

Dear Co-Chairs Sollman and Ruiz and Members of the committee:

My name is Benjamin Bloom. I am the Presiding Judge of the Jackson County Circuit Court. I have been a circuit judge for over 14 years, and in that time I have handled countless residential evictions. On my own behalf, and not as a representative of the Oregon Judicial Department, I am here to offer my support for fully funding Community Dispute Resolution through the Resolution Oregon program where funds pass-through the University of Oregon. I view increased funding for these services to be an access to justice issue and in that regard Community Dispute Resolution aligns with the Oregon Judicial Department's Strategic Campaign Commitment 1 to improve access to justice by enhancing service options. Mediation services are critical to the beneficial resolution of landlord-tenant cases. Our court mediators currently resolve approximately 75% of our landlord tenant cases, frequently allowing tenants to remain in possession of their dwellings and regularly avoiding eviction judgments on their records. In addition, because the mediation services are so successful, the judges of our court are able to hear other pressing matters set at the same time, including child custody cases and other domestic relations matters. This is why mediation is an access to justice issue. Our limited judicial officers are able to hear other pressing matters because of the success of the mediation services in landlord tenant cases.

Unfortunately, there are not enough mediators to provide all the services to tenants and property owners in residential eviction cases. Providing funding for dispute resolution helps maintain these services which in turn increases access to justice and provide better outcomes. For these reasons, I am urging your support of fully funding Community Dispute Resolution through Resolution Oregon.

Please accept this letter as our continued support of the Mediation Center and their impressive mediators. The Center should continue as a reliable asset to this community and region.



Community Mediation Services of Polk County is a valuable partner in our public safety mission, and I write to support funding for community dispute resolution centers. Community Mediation Services of Polk County has demonstrated a meaningful impact in our community for over 42 years.

Community Mediation Services works closely with the Juvenile Department to hold youth accountable for their actions and to assist those harmed by juvenile crime to be made whole. Using volunteer mediators, parties identify where restitution is needed, and these dialogues have a better than 90% chance of full payment of restitution to the victim. In the process the offender takes responsibility for his/her choices and learns about the impact it has had on the victim directly from the victim. This process is powerful for both the victim and the offender. Community Mediation Services has shown that 85% of offenders who participate do not recidivate.

As a REALTOR, I know that avoiding foreclosure not only avoids the cost to the homeowner, but also costs to taxpayers, the community and even the lending institutions. In these uncertain times where there seems to be little federal protection, CDRCs offer Oregonians some measure of support and control over the outcome of what is often the most stressful events in their lives. Furthermore, we conduct yearly trainings and monthly brown bags to try to teach more people how to mediate. We also offer facilitation services to help 501c3s get through conflict and neighborhood groups of new homeowners learn how to better interact so they can live more harmoniously with one another. We do so many great things that make Oregonians lives better, I hope you will continue to support CDRCs, as you have for the last 36 years.

Resolution Oregon's statewide network provides conflict resolution education for youth and adult community members, mediation services, and connects people to local support service providers (e.g., financial resources, legal aid, rehousing & credit counseling). For more than 40 years, these services have been shown to help communities improve graduation rates, reduce crime recidivism rates, and resolve disputes faster and cheaper than courts. These preventative services help reduce community costs for incarceration, health care, associated court costs, and keep people housed who are at risk of foreclosure and eviction.

Please help our vulnerable community members by investing in cost-effective mediation services that are complementary to other avenues for justice. Please fully fund Dispute Resolution in the Statewide Programs section of SB 5525.
