Testimony Template in Support of PSU's \$85M Request for the Performing Arts and Culture Center (PACC)

Dear Co-Chair Fred Girod, Co-Chair Rob Nosse, and Members of the Subcommittee on Capital Construction,

My name is Li Kuang, and I am a music professor at Portland State University, School of Music & Theater. I'm writing to voice my strong support for Portland State University's request for \$85 million in Article XI-G bonds to help fund the development of the Performing Arts and Culture Center (PACC).

As a music professor at Portland State University, the vision of a new, state-of-the-art performing arts building represents more than just bricks and mortar—it is a transformative investment in our students, our artistic community, and the future of our university.

For my students, many of whom come from diverse and often underrepresented backgrounds, this building would be a space of inspiration and opportunity. It would provide access to the kinds of professional-grade rehearsal spaces, performance venues, and collaborative environments that reflect the standards of the field they aspire to enter. It would validate their commitment to the arts and prepare them to thrive in a highly competitive world.

And for the university as a whole, a landmark performing arts building is not just about the arts—it is about identity, vision, and impact. It would stand as a visible and lasting symbol of PSU's commitment to creativity, interdisciplinary learning, and community engagement. It would open the door for deeper partnerships with Portland's vibrant arts scene and reinforce PSU's presence as a major urban university with a bold future.

This project is a once-in-a-generation opportunity. It has the power to redefine what's possible for our students and elevate the role of the arts on our campus and in our city. I am proud to support it and hopeful for what it will bring.

I urge you to fully fund PSU's \$85 million request. Let's invest in the arts, in students, and in the future of downtown Portland.
