Dear Mr. Chambers.

As I round out my first year as President of OBRC, I often find myself reflecting on the significance of your role and commitment to passage of Oregon's Bottle Bill 54 years ago.

While I did not have the opportunity to meet you, your devotion to protecting Oregon's rivers, trails, beaches and roadsides from beverage container litter continues to inspire me and the work of the Oregon Beverage Recycling Cooperative. I wonder if you could have imagined the multi-generational impacts your efforts would have on all Oregonians.

You helped forge unlikely alliances between environmental and industry groups, Republicans and Democrats, and you laid the groundwork for the unique public-private partnership that Oregon's industry stewardship model for beverage container redemptions represents today. This model delivers nation-leading results, year after year. A proud legacy indeed.

Our Bottle Bill achieved a 90.4% redemption rate this year, with more than 2 billion beverage containers processed back into bottles and cans, many of which were recycled right here in Oregon, and the others domestically in the U.S. We, along with our wonderful customers, supported more than 7,000 nonprofits this year from every part of Oregon, and hundreds of thousands of Oregonians tapped the magic of the Bottle Bill to save for college or disability support and to save on groceries.

We dedicate our 2024 Annual Report in your honor and to our public and private partners that collectively make Oregon's Bottle Bill the top performing deposit return system in the country.

Thanks to strong relationships with our partners and the high level of participation in the system, we're driving positive change for Oregon, one container at a time.

2024 by the Numbers

For the third straight year, Oregonians redeemed and recycled over 2 billion containers through Oregon's Bottle Bill, and for the second time since 2019, OBRC's preliminary redemption rate crested 90%. That's a direct result of convenient access provided through a statewide network of return options. Individuals and nonprofits received over \$206 million in refunds in 2024, and Oregonians everywhere enjoyed the outstanding environmental and recycling outcomes the system helps deliver.

Revving the Engine on Network Access and Efficiency Gains

OBRC expanded access to the Green and Blue Bag program in partnership with retailers, including the first bag drop site at a WinCo Foods store, which is located on Southeast Powell in Portland and a Dealer Redemption Center at the Target Tanasbourne in Hillsboro.

In 2024, we also expanded access to our high-efficiency container processing technology, including **Smart Count AI** (back of house at BottleDrop Redemption Centers and in processing plants – processing bags four times faster than alternative tech) in Clackamas, Redmond and Oregon City, and our **Stream Count AI** (front of house at Redemption Centers – counting 350 containers in two minutes vs. 20 minutes with reverse vending machines) in Eugene and Oregon City.

Turbocharging Positive Change with Give Matching Campaigns

In 2021, Earth Week Give was launched to celebrate Earth Day while providing an extra boost for participating nonprofits during the spring. The 4th annual Earth Week Give promotion was held from April 22 - May 4, 2024. A total of 947 nonprofits participated and raised over \$250,000 with OBRC's help.

The Oregon Beverage Recycling Cooperative proudly supports thousands of local nonprofits who fundraise year-round with BottleDrop Give. OBRC hosts two annual promotional campaigns, Earth Week Give and Holiday Give, where fundraisers can engage their supporters and make donations go further. During these special events, participating nonprofits earn a 20% match on all funds raised through BottleDrop and have a chance to win prizes in a social media contest.

Holiday Give has been helping nonprofits earn extra funds around the holiday season since 2017. The 8th annual Holiday Give event was held from November 15 - December 2, 2024, and a record-breaking 1,152 nonprofits participated. In total, they raised nearly \$300,000, including match funds and prizes.

Since their inception, these promotional campaigns have helped nonprofits raise more than \$2 million, with more than half a million dollars being raised during Earth Week Give and Holiday Give in 2024 alone. OBRC looks forward to hosting these events again in the future.

Container redemption is about more than just the refund value. Oregon's Bottle Bill boosts community organizations across the state, helps keep Oregon beautiful by reducing litter and waste, reaches new heights through creative partnerships and continues to improve through relentless innovation.

In 2024, BottleDrop account holders transferred **\$518,166** to **5,173** Oregon College and ABLE Savings Plan accounts. Oregon is the only place in the world where people can directly save for education through container redemption.

226,699 BottleDrop account holders took advantage of BottleDrop Plus in 2024, making their redemption dollars stretch farther by getting an extra 20% added to their refunds to shop with in-store credit at participating retailers. That's a **4% increase** from 2023.

OBRC Helps "Cans for Kids" Recover After Theft

The Illinois Valley Community Development Organization (affectionately known as IVCanDO) has been supporting their community since 1995. Founded by dedicated volunteers in rural Josephine County, they work to improve the quality of life for residents, businesses and organizations in Cave Junction, Kerby, Selma, O'Brien, Takilma and surrounding communities.

In 2018, IVCanDo launched a program called Cans for Kids that does exactly what its name implies - they collect donated redeemable cans and bottles to support youth-focused organizations. Since the program's inception, they have distributed nearly \$150,000 to programs in their community. The Oregon Beverage Recycling Cooperative helps facilitate this community donation program by picking up the containers from their drop off location and paying the refund value to IVCanDo.

In early 2024, the Cans for Kids trailer was vandalized and burglarized on multiple occasions. The perpetrators stole a substantial amount of aluminum cans and plastic bottles and damaged the collection container itself.

IVCanDo reached out to OBRC to alert them of the incidents, which inspired OBRC to pay it forward. OBRC's Containers for Change program helps support community organizations that are operating in the spirit of Oregon's Bottle Bill, like the Cans for Kids program. OBRC donated \$2,000 to help

cover the value of the stolen containers and worked with them to help deter the vandals.

"When we learned that somebody had recently stolen the containers they use to provide those programs, we wanted to be part of the solution," said Devon Morales, Vice President of External Affairs of OBRC. "Oregon's Bottle Bill does a great job of preventing litter and dramatically increasing recycling rates, but its strength is most pronounced when community groups harness the power of containers to provide



critical services in their communities. We're proud to be a partner in that."

"Cans for Kids has long been a beloved source of support for the youth in the Illinois Valley, promoting environmental sustainability through recycling and distributing the proceeds to local youth-focused initiatives," said Anna Wiley, Communications and Outreach Manager at IVCanDO. "The recent theft could have threatened the program's ability to fulfill its mission, but the support of our community and partners like OBRC will help Cans for Kids recover its losses and continue its valuable work."

Thank You to Our Partners in the Success of Oregon's Bottle Bill

The success of Oregon's Bottle Bill has long been a source of pride for Oregon. As the first in the nation, the policy and system have been continuously iterated upon to meet the needs of the day. Those iterations came about through the experience and instinct of beverage distributors working with partners to devise and implement convenient and efficient methods for Oregonians to get their deposits back and to maximize the benefit of the program for the state that we all love.

From the very beginning, retailers large and small have played a fundamental role in providing convenient access for consumers to redeem their containers in every community in Oregon.

Large format stores such as grocery stores are critical to the success of the Oregon model. Representatives from the **Northwest Grocery Retailer Association** collaborated with OBRC to come up with the vision for the convenient options that now make up the BottleDrop network. Nearly 1,000 active large format retailers across Oregon provide access for redemptions through a mix of options, and OBRC appreciates the longstanding partnership and the ability to work together to come up with solutions that serve all Oregonians. In addition, Oregon's nearly 2,000 active small format stores provide access to redeem containers across the state in both rural and urban areas. OBRC is grateful for these important partners and the role they play in allowing Oregonians to participate in their Bottle Bill.



Accountability is also essential and as the program regulator, the **Oregon Liquor and Cannabis Commission** is critical to ensuring parties are following through on their responsibilities under the Bottle Bill so consumers can access their redemptions when and where they need them. OLCC is an important partner in helping Oregonians navigate their Bottle Bill, including understanding their rights and guidance for how to use the system.

Nonprofit partners like SOLVE magnify the impact of Oregon's Bottle Bill and demonstrate that a redeemed container can be worth so much more to Oregon than 10 cents.

The Oregon Bottle Bill's nation-leading results would not be possible without our partners and the important roles they play in the success of this system.







BottleDrop Community Raised \$40,000 to Support Wildfire Relief in Oregon

In 2024, Oregon experienced a record-breaking wildfire season, with nearly 2 million acres burned across the state. The Oregon Beverage Recycling Cooperative helped facilitate container redemptions for the boots-on-the-ground wildland firefighting camps to help them recycle their beverage containers. Inspired by their efforts, combined with the devastation caused by these wildfires, OBRC activated its Emergency Fund to aid relief efforts and invited Oregonians to support the cause through beverage container donations.

"At OBRC, we are both in awe of the tireless resolution of the brave first responders who are risking their lives to protect their fellow Oregonians and deeply saddened by the devastation to our beautiful state caused by the all-too-common wildfires," said Devon Morales, Vice President of External Affairs at OBRC. "BottleDrop customers are incredibly generous, and we are proud to work together to leverage the power of bottles and cans to support organizations that are making a big difference for communities impacted by wildfires."

From mid-August through the end of September, customers were encouraged to donate containers in-person at any of the 27 full-service BottleDrop Redemption Centers. Additionally, Green Bag account holders could donate online from their available account balance.

An astounding 116,832 containers were donated in-person, and 186 Green Bag customers donated online through their BottleDrop accounts, resulting



in \$17,422 raised by individual supporters. OBRC matched all donations, plus contributed additional funds, to round out the total amount raised to \$40,000.

Funds were evenly distributed to four nonprofits that provided direct assistance to ranching and farming families impacted by wildfires:

- Oregon Cattlemen's Association's Wildfire Fund
- Oregon Farm Bureau's Wildfire Relief Fund
- Oregon State University Foundation's Post-Fire Recovery Fund
- Oregon Chapter of the Wildland Firefighter Foundation

"We are awestruck and humbled by the generosity of those Oregonians participating in this program and OBRC for matching each donation received," said Matt McElligott, President of Oregon Cattlemen's Association. "With sincere appreciation, we thank everyone who has so graciously and selflessly donated to help your fellow Oregonians in a time of such great need."
