Re: Opposition to SB 1061: Relating to lumber grading training program

Dear Chair Helm and members of the House Committee on Agriculture, Land Use, Natural Resources, and Water,

The Western Wood Preservers Institute (WWPI), Treated Wood Council (TWC), National Hardwood Lumber Association (NHLA), Pacific Lumber Inspection Bureau (PLIB), and North American Deck & Railing Association (NADRA) are writing to express our strong opposition to SB 1061, which establishes a lumber grading training program at Oregon State University's College of Forestry. SB 1061 is scheduled for a public hearing in your Committee on May 12, and we ask you to

add our opposition as part of any public testimony. We are concerned that SB 1061 would cause unforeseen health and safety issues.

SB 1061 would circumvent the national accreditation process administered by the American Lumber Standard Committee and the National Hardwood Lumber Association. While SB 1061 is intended to help the timber industry grade lumber, we don't understand the problem it seeks to solve. Transient inspection services offered by an accredited lumber inspection agency will increase the amount of lumber that is graded. Transient inspection service is ideal for portable sawmill operators and meets building codes and standards.

Lumber grade stamps ensure that lumber used in construction is of the required quality, and confirms that it can safely support the loads it is intended to carry. Lumber produced and grade stamped by a mill under the supervision of an ALSC accredited agency is regularly monitored to verify that it meets United States standards for lumber sizes, moisture content, and grade characteristics set forth in Voluntary Product Standard PS20, the National Grading Rule, and regional grade rules. These rules and standards are developed to ensure uniformity in establishing structural design values and structural integrity of the lumber. The lumber that would be "graded" under this program would not be subject to the rigorous accredited agency inspection requirements. To bypass Oregon building code, the bill requires the Department of Consumer and Business Services to design and provide forms that certify lumber has been "graded." However, there are no safeguards to ensure the form will be used for the lumber that was "graded." Additionally, there are no requirements for regularly verifying that standards are being met. This will create excessive liability issues for future building owners, insurance companies, and mortgage lenders, none of which will have the knowledge that the lumber "graded" and used in the structure do not meet national building codes and standards.

Residential decks and patios are built with preserved wood. Preserving wood will protect these structures from insect or microorganism decay. Wood preserving companies only treat lumber that has been grade-stamped by nationally accredited agencies. We are strongly opposed to self-grading, as allowed by SB 1061. Finally, we support the comments submitted by the American Lumber Standard Committee submitted on May 5th.

Thank you for giving us the opportunity to share our strong opposition to SB 1061. We are requesting that you vote against SB 1061.
