RE: City of Florence Support for SB 5531

Dear Co-Chairs Senator Girod and Representative Nosse and esteemed members of the subcommittee,

The City of Florence is working with Lane Community College (LCC) to create a Living Learning Planned Unit Development (PUD) on land jointly owned by these two entities. This 10-acre parcel of land is zoned high-density residential, and the hope is that this development can address the local need for adequate and affordable workforce housing – while offering on-site education-related opportunities that meet the needs of the community and LCC.

The challenge to developing this property is access. It is currently undeveloped and landlocked behind the LCC Florence Center. Estimated costs to build out the public street and utility infrastructure, including electricity with Central Lincoln People's Utility District, is \$6.9 million. With this public funding, the property could support 250 units of much-needed workforce housing for our professionals making 80 to 130% of AMI. This includes local educators, medical providers, child care workers, and our business community.

The Florence City Council prioritizes housing efforts and initiatives in our upcoming 2025-2027 Work Plan. This project is a significant work plan item that will address several council goals and bring relief to the desperate need in our community for workforce housing.

The project is currently in the design phase, with the City seeking infrastructure funding to pay for streets, water, wastewater, stormwater, and electrical to bring these public utilities to the property. Lane Community College and the City will then conduct a selection process for a private development partner(s) to build out the 250 units of workforce housing. With full funding for the public infrastructure, we expect the housing could be built within two years after the receipt of public infrastructure dollars.

The City of Florence and other local partners plan to bring a 20% match to this Living Learning Planned Unit Development, contributing a total of \$1.38 million to the project. We request \$5.52 million to help us build out the infrastructure for this important workforce housing project.
