I have witnessed firsthand the critical role the Center plays in our community. Their dedication to serving those in need is unwavering, and their impact is far-reaching. In the past 12 months alone, The Center has provided over 32,000 services at no cost to our most vulnerable residents.

The Center's programs are essential to the well-being of our community. Their Reading Mentors program actively strengthens learning effectiveness for children in Canby schools, providing one-on-one reading time with adult mentors for emerging readers. Currently, this program serves 140 students. Additionally, the Backpack Buddies program provides food packs each Friday for over 300 food-insecure children, ensuring they have access to nutritious meals. The Quest youth mentoring program offers one-on-one tutoring to strengthen core class skills for middle school children, empowering them to succeed academically.

Furthermore, the Center has provided over 20,000 meals to local residents in need through their Harvest Share food distribution, hot lunches served four days each week, and emergency food boxes for those with urgent food needs. These programs alleviate hunger and food insecurity, ensuring that our community members have access to the nourishment they need to thrive.

The Center's capital campaign will enable them to expand their services, improve their facilities, and better serve our community.
