Mittleman Jewish Community Center Enhance Accessibility and Expand Childcare for the Entire Community

The MJCC has served Oregon since 1914, making it one of the oldest Jewish Community Centers in the country. The MJCC is a center for all Oregonians, with more than half of those walking through our doors not identifying as Jewish. The current facility has been occupied since 1971 and is in need of repair to allow the MJCC to continue providing services to all Oregonians.

MJCC is conducting a capital campaign, and we've engaged private donors for this \$10 million project. MJCC will use private funds to ensure ADA accessibility and compliance throughout our shower and changing room facilities. Based on anticipated construction phasing, MJCC is requesting \$5 million in lottery-backed bonds from the Legislature as the "last dollars in" to complete the project.

Enhance Accessibility for Community Members - \$4 Million in lottery-backed bonds

The MJCC has the only publicly-accessible warm water and therapy pool in the Portland metropolitan area. Many seniors, as well as children, rely on the pool for rehabilitation, exercise, and therapy. The MJCC partners with area organizations and hospitals to allow patients to visit the MJCC as part of their rehabilitation journey. This pool is in need of maintenance to continue its operations, and the areas around it must be

improved to ensure appropriate safety.



Swimming Pool

In the Portland area, there are few publicly-accessible swimming pools available to families. The only outdoor pool in SW Portland near the MJCC is operated by Portland Parks at Ida B. Wells H.S. It is massively overcrowded during the summer months. To ensure that the MJCC's pool area is welcoming for all, the MJCC will create a new outdoor, ADA-accessible area for families, immediately adjacent to its main pool, which will reduce overcrowding and provide more options for families looking to cool down.

Working parents need childcare during the day. MJCC has several racquetball courts that are no longer used for those purposes. Converting these courts to allow for the provision of short-term, drop-in daycare services and afterschool programs, as well as day camps when local schools are closed, will help address unmet needs in the Portland community. The MJCC is centrally located in SW Portland to allow for all community members with these types of needs to utilize these services.
