My name is Robert M. Richard, D.C., and I am current Vice President of the OCA.

The Oregon Chiropractic Association supports:

- Any willing provider.
- The ability of all professions to practice at the top of their scope of license.
- The ability of any profession to expand their scope with proper education.
- Non-discrimination, inclusion, diversity, equity and parity in insurance,
- reimbursement, and patient access.
- Public safety.

The OCA does NOT support:

- LIMITING or DIMINISHING scope of practice.
- LIMITING or DIMINISHING access to care.
- LIMITING or DIMINISHING public safety.

Therefore, the OCA is opposed to HB3824 (as written) as it conflicts with existing ORS and would LIMIT and DIMINISH scope of practice of chiropractic and acupuncture.

Current ORS 684.010 (2)(a) Defines chiropractic as:

That system of adjusting with the hands the articulations of the bony framework of the human body, and the employment and practice of physiotherapy, electrotherapy, hydrotherapy, and minor surgery.

As written, HB3824 Section 11, (4) re-defines Physical Therapy as:

Unless physical therapy services are provided by a physical therapist...the entity (chiropractic/acupuncture) MAY NOT USE IN CONJUNCTION WITH ENTITY'S NAME OR ACTIVITIES... "physiotherapy," "physiotherapist," "physio."

HB3824 conflicts with existing ORS and would have the negative effect of LMITING and DIMINISHING scope of practice of legally defined existing professions.

HB3824 Section 9, (9)(b) Presents a public safety risk by DRASTICALLY expanding the scope of Physical Therapists and Physical Therapy ASSISTANTS beyond their current education and their ability to ATTAIN such education.

• Assess disability: AMA Sixth Edition requires up to 160 hours and 200

modules

- Needle insertion: wet and dry needles require training and board certification
- Manual therapy including manipulation requires 200 2000 hours of training
- Prescription application requires 120 hours minimum 400 maximum.
