“Gun Control” laws are tyranny of law-abiding citizens, pure and simple!

Second Amendment To The Constitution of the United States:

A well regulated Militia, being necessary to the security of a Free State, the right of the people to keep and bear Arms, shall not be infringed.

It's pretty clear in the Constitution that the militia is the whole of our citizens, separate from our standing army. The militia can be called upon to protect us from invaders/insurgents from without and from within.

“Gun Control” laws are not designed to keep guns out of the hands of criminals or to reduce crime, “Gun Control” is designed to control citizens and eliminate our ability to defend ourselves and to resist a corrupt government as we did in 1776. No country has yet attempted to invade America because with so many citizens owning guns they could never hope to defeat an army that large. The Japanese knew this in WWII.

The first “gun control” law passed was The National Firearms Act of 1934 (NFA). It was supposed to stop the violence that accompanied Prohibition by controlling access to automatic firearms, sawed-off shotguns and even silencers. What did this law do? It raised the price that criminals had to pay to buy an automatic firearm such as a machine gun. Lawmakers took the easy road by ignoring our Constitution and restricting honest citizens rather than embrace technology or punish the criminal. It is the same with every “gun control” law passed since.

The attempt to keep guns from law abiding citizens has been counter productive and instead has emboldened the criminal. The proof of this is increasing gun related crime and murders, gang and drive-by shootings and more. Still lawmakers keep passing “gun control” laws that do nothing to prevent crime or punish criminals and refuse to focus on real solutions.

Congress and the courts have chosen to use gun crime as a false means of reducing crime through “gun control” and the reality is that their true purpose has been exposed. Any lawmaker who claims that “gun control” helps eliminate crime is a liar and they know they are a liar. Any judge or combination of judges who claim that “gun control” laws reduce crime is also a liar and they know they are a liar. THE TRUE AIM OF “GUN CONTROL” IS TO CONTROL OWNERSHIP OF GUNS BY LAW ABIDING CITIZENS.

No “gun control” law including the NFA of 1934 is valid. No law restricting the “right of the people to keep and bear Arms” ever passed is valid. They are all false because they violate our Constitution and therefore have no force or effect. Any politician or judge who proposes or supports laws that restrict the right of law abiding citizens to own firearms has the same socialist belief that Hitler did, to disarm the public so they can no longer resist. The only purpose and end to “gun control” laws is tyranny and a totalitarian state and if we knuckle under and allow the state to control us instead of controlling them we are doomed to state bondage.

Much stiffer penalties for crimes committed with firearms are needed. More demands on courts to mete out those punishments and fewer loopholes to allow criminals who use guns to commit crimes to escape justice are also needed.
