

Testimony on HB 2006
House Committee on Rules

I am writing in support of HB 2006 which would limit the number of bills that a legislator may initiate during the long session. I have been frustrated for several years, watching the number of bills grow each session to way more than what can be addressed during the session.

I previously wrote the Senate President and the House Speaker, over a year ago, asking them if they could limit the number of bills that get submitted during the long session.

In the short session, legislators are required to prioritize their wishes due to the 2-bill limit. The long session is 4 times as long, so you might make the case that the limit during the long session should be 8 bills.

Thanks to the OLIS data system and the ability to extract a lot of the data, I present the following facts.

Measures

In the current session (2025), 3442 measures have been introduced.
2496 of these measures had a chief sponsor listed, which is about 3/4 of the measures.
946 measures were introduced by someone other than a legislator (1/4 of the measures).
On average, each legislator introduced 28 bills, although 3 legislators accounted for 593 bills. Please see Exhibit 2 below for a count of bills by chief sponsor.

Hearings

Of the 3442 measures that were introduced, only 1649 had a hearing (48%)
The bills that had a hearing can be divided into two groups:

1. Legislator-introduced measures: 1083 (Average of 12 per legislator)
2. Staff-introduced measures: 566

The 1793 bills that did not have a hearing (52% of total) can be divided into two groups:

1. Unheard legislator-introduced measures = 1413
2. Unheard staff-introduced measures = 380

Please see exhibit 1 for a graphical representation of these numbers.

While I greatly support the passage of HB 2006, I also recommend amendments as follows:

1. Reduce the number of measures that a legislator can introduce to 12, for a total of 1080 in both chambers.
2. Require committee chairs to hold a public hearing and work session on each measure that is introduced.
3. Require staff, agencies and the governor to work with a legislator to introduce staff measures, allowing each legislator to introduce 6 of these measures. (Please refer to SB 1006)

Passing HB 2006 with these proposed amendments will result in high-quality measures being introduced and will require legislators to prioritize their work. It should also be mentioned that currently, duplicate bills are being introduced by lawmakers. There should be a mechanism to allow lawmakers to collaborate and consolidate bills. A case in point is the more than 20 bills on the estate tax that were introduced this session.

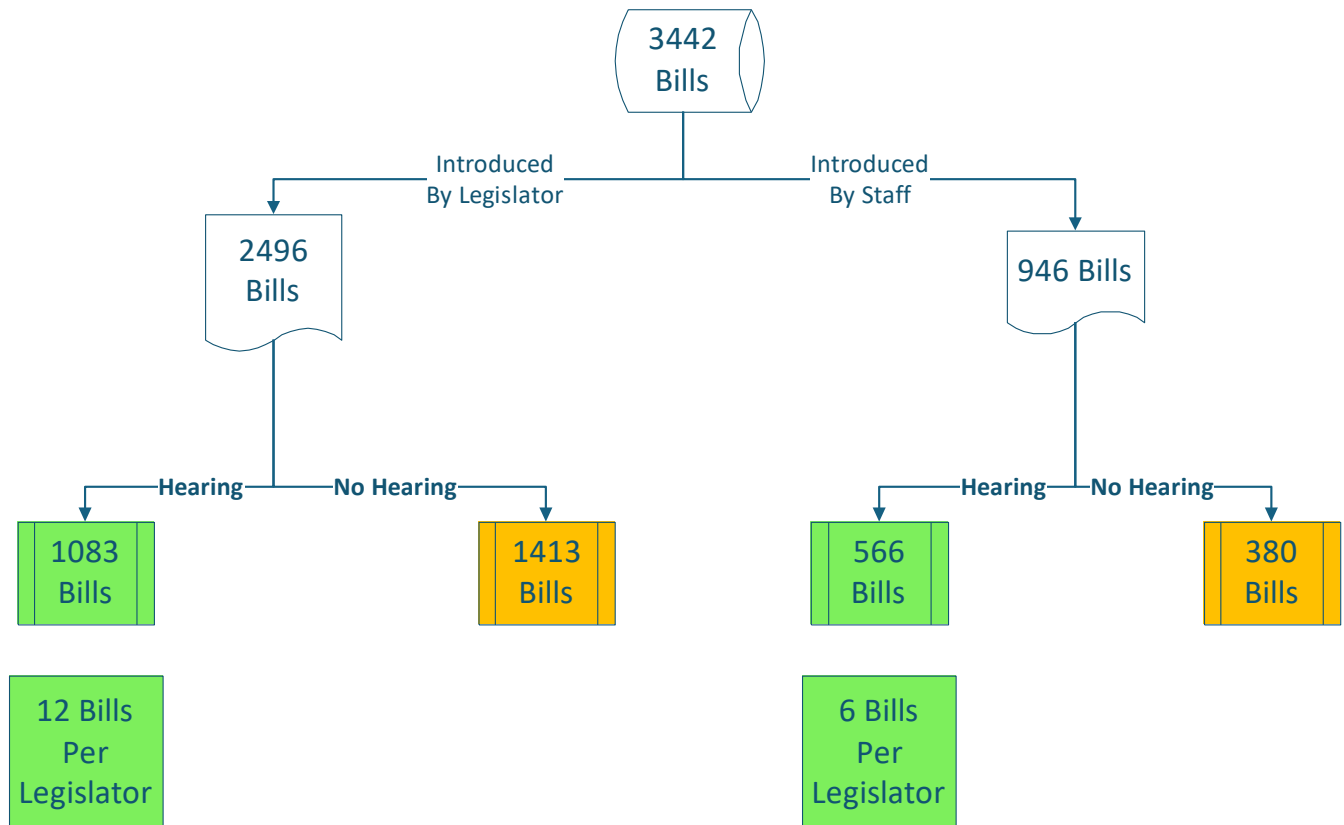
