I've nearly been hit both during my travel to and from work but also while heading to spend that hard earned money. all had the white hand signal motioning me to cross a road or highway. I do not jay walk and follow all rules but it's not enough.

Two of my coworkers were hit on their bikes. One of them faced a long time without a new bike because it was too expensive to replace.
