To the Joint Committee on Transportation Reinvestment:
I've read that the below are the 7 stages of addiction.
Initiation.
Experimentation.
Regular Usage.
Risky Usage.
Dependence.
Addiction.
Crisis/Treatment.
Here's how the Stages of Addiction translates to Oregon's Democrat super-majority:

Initiation - At some point, the idea of taxing businesses and consumers through a variety of ways to allegedly help pay for something in the state comes to mind. For the alcoholic, taking that first drink of an alcoholic substance is an initiation into something that, for many, can be maintained with moderation, but for some can turn into something more harmful.
