BOARD OF BOILER RULES

The Governor has appointed the following individual to the Board of Boiler Rules subject to Senate confirmation.¹

Composition³

The board has 12 members:

- one owner and user (or representative of) of a high-pressure boiler, with practical experience with high pressure boilers (LANGLEY);
- one manufacturer (or representative of) of boilers or of pressure vessels (VACANT);
- one boilers and pressure vessels inspector, employed by an insurer who writes boiler and pressure vessels explosion insurance policies (ENGLE);
- one registered mechanical engineer (**ANDERSON**);
- one boilermaker (BEACH);
- one owner and user (or representative of) of a low-pressure boiler (CONNOLLY);
- one owner and user (or representative of) of a pressure vessel, with practical experience with pressure vessels (RAPP);
- one owner or employee of a boiler installation and repair business (DUNN);
- one steamfitter (BAIER);
- one practical steam operating engineer (LAMB);

- one public member, not otherwise eligible for appointment (GARVEY); and
- the chief boiler inspector, the board's nonvoting secretary (VACANT).

Members are limited to two full four-year terms.

Duties⁴

The board formulates and promulgates rules for the safe construction, installation, inspection, operation, maintenance, and repair of boilers and pressure vessels. Its duties include

- adopting rules for, and engaging in, administration, examinations, regulation, and enforcement;
- providing continuing education;
- setting fees; and
- hearing appeals and imposing fines.
