STATE BOARD OF DENTURE TECHNOLOGY

The Governor has appointed the following individual to the State Board of Denture Technology subject to Senate confirmation.¹

Composition³

The board consists of seven Oregon residents, including:⁴

- four licensed denturists (CHAPMAN, FARRIS, SMITH, **YOUNG**);
- one Oregon-licensed dentist in active practice (SCHWANDT); and
- two public members who do not possess the professional qualifications of other members and who are not a spouse, domestic partner, child, parent, or sibling of an actively licensed denturist or dentist (FERGUSON, VACANT).

Members serve three-year terms; the board must meet at least once each year and annually elect a chair.⁵ Board members required to be denturists may be selected from a list of three to five nominees, submitted by a professional organization representing denturists.
