HB 4105 **

**Subsequent Referral(s) to Ways and Means

CARRIED OVER FROM 2/11/2026 MEETING: Directs the State Forester to determine the available state forestland, establish sustainable harvest levels for harvesting timber on state forestland and manage available state forestland.

Work Session

HB 4006

Authorizes holders of certain Columbia River water rights to change the point of diversion or use the water right on land to which the right is not appurtenant, provided certain conditions are met.

HB 4153

Allows counties to approve farm stores, instead of farm stands, as nonfarm use on lands zoned for farm use.

HB 4049

CARRIED OVER FROM 2/11/2026 MEETING: Directs the Water Resources Commission to encourage and approve voluntary agreements between ground water users in the Greater Harney Valley Groundwater Area of Concern to achieve reasonably stable ground water levels.
