HB 4083

Requires the Oregon Health Authority to, no later than June 30, 2027, adopt a uniform process for credentialing organizational behavioral health providers and establish a centralized portal for processing applications.

Public Hearing

HB 4068

Modifies the definition of "transition aged youth residential treatment home" to include young adults between the ages of 17 and 25.

Public Hearing

HB 4069

Requires a behavioral health employer to develop and implement a written safety plan.

Public Hearing

HB 4028

Imposes requirements and restrictions on insurer and coordinated care organization audits of claims for reimbursement submitted by behavioral health treatment providers.

Public Hearing

HB 4115

Provides that a criminal records check on certain caregivers shall last for three years,
